Sub: Consent of extension of approval of affiliation to Nawada Vidhi Mahavidyalaya, Nawada, Bihar for imparting three year LLB and five year BA LLB course with an intake of existing strength of students.

Sir,

The Bar Council of India at its meeting held on 2nd May, 2015 considered the inspection report of the above mentioned college. After consideration the Council decided as follows: -

The Bar Council of India considered the inspection report submitted by the inspection team. After consideration, Council is of the view that Nawada Vidhi Mahavidyalaya, Nawada, Bihar be granted extension of approval of affiliation for running three year LLB course with an intake of existing strength of students in each section and five year BA LLB course with an intake of existing strength of students for a period of three years i.e. for the academic years 2014-2015, 2015-2016 and 2016-2017 subject to the following conditions:-

1. The building in which three years law classes is running required white wash and repairing. The college authorities are directed to carry out the whitewash and repairing work in the college.
2. Moot court in the both the places are required to be improved. Infrastructure facilities are there but furniture is not suitable therefore, the college is directed to purchase moot court furniture immediately such as dias, table for the judges within two months.
3. The college to provide Legal Aid to the general public. The college should properly run the Legal Aid Clinic awakening the course and due publicity thereof to be made in the surroundings area.
4. College should ensure the payment of salary to teachers as per Rules 22 schedule III, Part IV of BCI Rules.

5. The institution is directed to upgrade the library by investing minimum Rs. 50,000/- per year per stream.
6. Teacher Student ratio shall be as per Schedule-III, Rule-11, Clause-17, Part-IV of Bar Council of India Rules.


Institution should submit affidavit in compliance to the above conditions within six weeks.

However, question of granting fresh approval of affiliation to five year BBA LL.B course cannot be accepted since college has deposited the inspection fee after inspection.

College authorities are also required to apply to the Bar Council of India for further extension of approval six months in advance before expiry of the period of approval of affiliation granted by the Bar Council of India i.e. on or before 31st December, 2016 in respect of three year LLB and five year BA LLB courses.

This is for your information and necessary action.
